Introduction

The following is the Regional Work Program of the Heart of Georgia Altamaha Regional Development Center which describes the specific actions and activities the staff and Board of Directors have chosen to undertake to implement the plan over the next five fiscal years. These actions include only those determined reasonable and feasible for the agency given its limited missions of technical assistance and coordination for and on behalf of its member local governments and the State of Georgia. As part of the RDC Regional Work Program, at least one of the plan's recommended consistent implementation actions is included for each identified need, goal, objective, and every policy statement/priority in the plan. As noted earlier, not all of the "recommended consistent implementation actions" of the plan are included in the RDC Regional Work Program. The recommended consistent implementation actions of the plan were included as a menu of specific "how-to" ideas beyond the general guidance of required policy statements/priorities for any party interested in implementing the plan and improving the region. The RDC Regional Work Program is in the format of a spreadsheet that includes a description of each included implementation action/strategy, a cross-reference to the plan element and policy statement/priority addressed, a proposed timeframe for implementation of each activity, an identification of parties (other than the RDC) responsible for or assisting with implementation, and estimated costs/funding sources.
